Due to materials failure of the original widow installation of the Camas Library, it is necessary to repair the damaged areas of 20 identified windows. Previous estimates exceeded \$20,000. The scope of work was modified to fit within the budget. The estimate for this project was \$7,046, including tax, only one bid was submitted by JWC, LLC for \$11,463, including tax. - D. Authorize Release of Retainage for Project No. P-862 Lacamas Lake Lodge to JWC LLC in the amount of \$88,324.79. This project provided for the construction of the Lacamas Lake Lodge facility. All required work has been completed and all City and State project documentation has been received and verified.

In 1991, the City and James River entered into a property transaction where the City sold the old City shop on SE 6<sup>th</sup> along with the then current City shop on East First Street and James River sold the City the land on Polk Street where the Operation Center is currently located. A recent property transaction with the old City shop on SE 6<sup>th</sup> has brought to light a discrepancy between the building location and the land description. Stewart Title contacted City

staff to request a file review for any relevant information regarding the property. After review, staff located a 1945 fully executed deed for the strip of land in question. The excise tax was paid in 1945 but it does not appear the deed was recorded. After discussion with the City Attorney, Stewart Title will prepare a Quit Claim Deed for the strip of land. This transaction will not provide any additional income to the City. The City will not incur any cost associated with the recording or processing of these documents. #### VIII. COMMUNITY DEVELOPMENT

- A. Public Hearing to consider a Community Development Block Grant application submittal for the rehabilitation of NE Franklin Street from 15<sup>th</sup> to 19<sup>th</sup> Avenue.
  - Details: On October 6<sup>th</sup>, Staff proposed to Council the submittal of a CDBG grant application for the 2015 funding cycle. The proposal includes the request for \$215,000 in grant money to partially fund improvements to NE Franklin Street between NE 15<sup>th</sup> and NE 19<sup>th</sup> Avenues. The total cost of the proposed project is \$422,000. Improvements will include rehabilitation of the existing sewer main and service laterals, new water services, hydrants, curb ramps, and resurfacing the existing roadway. Staff recommends opening the public hearing and considering public testimony. The CDBG program requires that two public meetings be held prior to application submittals. This public hearing, in conjunction with the October 6<sup>th</sup> Workshop discussion fulfills this requirement.

Mayor Higgins noted that Mayor Pro-tem Hogan may need to conduct the special meeting if it is held. The Mayor will be out of town and his plane may not arrive in time for the meeting.

Capell gave Council an overview of the meeting that he had with Lacamas Swim and Sport regarding the operation of the Crown Park Pool. The net proceeds will be used to purchase items that were acquired specifically for the Crown Park Pool. The remainder of the proceeds will be split between the City of Camas and Lacamas Swim and Sport.

Capell informed Council that Baseball Tomorrow will be meeting with City staff and a representative from Camas-Washougal Babe Ruth on November 17th. Baseball Tomorrow is an element of Major League Baseball that helps to provide funds for these types of programs. The purpose of the meeting will be to discuss improvements at Louis Bloch Park.

#### IX. COUNCIL COMMENTS AND REPORTS

Capell responded to Hogan's inquiry about the use of the Babe Ruth field at Louis Block Park.

Hogan mentioned that he will be attending a community advisory panel meeting at Georgia Pacific on Wednesday.

Smith attended a chamber meeting. She also gave Council a brief overview of the Association of Washington Cities (AWC) regional meeting that she attended.

Chaney asked and Capell responded that Camas' legislative priorities need to be finalized by the end of the year. Discussion about the priorities ensued.

Hazen attended the grand opening for Cake Happy.

Anderson attended the AWC regional meeting and the candidate forum sponsored by the Camas Youth Advisory Council (CYAC) that was held at the Camas High School. He will also be attending a Fire Consolidation Joint Policy Advisory Committee meeting on Thursday. Anderson encouraged Council to donate to the Downtown Camas Association (DCA). The proceeds from the fundraiser will be used for tree lighting in the downtown area.

Turk gave Council a brief overview of the Community Center Development Committee (CCDC) and the Camas 2035 Vision Steering Committee meetings that she attended. She will be attending the Planning Commission meeting on Tuesday. She added that the next Camas 2035 Vision Steering Committee workshop will be held on November 5, 2014, at the Grass Valley Fire Station at 6:00 p.m. Mayor Higgins noted that the CYAC will be participating in the visioning survey.

Mayor Higgins commented about an injury that occurred during the Camas High School football game with Union on Friday night.

#### X. PUBLIC COMMENTS

Chris Kralik, 631 NW 18th Loop, Camas, stated that he appreciated the update provided by the CWEDA.

The meeting adjourned at 6:08 p.m.



The City has previously contracted on an annual basis with The Northwest Regional Training Center (NWRTC) to provide safety training required by the Washington Administrative Code and additional training that is industry specific.

Contract for services between NWRTC and the City of Camas for the calendar year 2015, for the following services:

- Classroom Safety Instruction and Training
- Maintenance of all Safety Training Records
- Notification and Scheduling of Training Classes
- Assistance with Labor and Industries Audits

Contract is for \$10,912.00, broken into quarterly installments of \$2,728. Training is based on 59 regular employees at \$168 each and 10 seasonal workers with a rate of \$100 each.

Training courses provided under this agreement:

Bloodborne Pathogens Fall Protection & Aerial Booms Confined Space Training Rigging Defensive Driving Fire Extinguisher/Evacuation First Aid/CPR Flagging and Traffic Control Forklift Training Emergency Response Awareness Hearing Conservation and Testing Lockout/Tagout Training Respirator Protection and Fit Testing Trenching and Shoring

### CONTRACT FOR SERVICES

### SAFETY AND COMPLIANCE PROGAM

The Northwest Regional Training Center (Training Center), under the direction of Clark County Fire District 5, and the City of Camas (City) hereby agree to the following program for calendar year 2015.

- A. Services to be Provided The Training Center shall provide safety training to City employees as follows:
  - <u>Classroom Instruction and Training</u> The Training Center will make available to City employees classroom instruction and training in all OSHA and WISHA required areas, as outlined in Appendix B. This training may occur at the Training Center facilities or at another site designated by the City, as agreed upon by the Safety Program Manager and the City.
  - 2. <u>Maintenance of all Training Records</u> The Training Center will maintain a database of all training that is conducted for the City. Reports showing all training conducted year-to-date will be provided to the City monthly.
  - 3. <u>Notification and Scheduling of Training Classes</u> The Training Center will provide the City with notification of classes to be conducted. This information will be provided by the fifteenth of the month prior to the upcoming quarter. For example, the City will be notified by March 15 of classes to be provided during April, May, and June.
  - Assistance with Labor and Industries Audits Training Center personnel will be available to assist the City with all records and information associated with training conducted by the Training Center. This will include copies of class rosters, training curriculum, and competency records (if needed).
- B. Responsibilities of the City The City shall be responsible for the following:
  - 1. <u>Listing of Employees by Division</u> The City shall provide the Training Center with a roster of employees who will need training, broken down by division.
  - Assistance in Determining Required Training The City shall work with the Safety Program Manager in determining what type of training is needed for personnel in each division.
  - Notification of Intent to Attend Classes At least 7 calendar days prior to a class being conducted, the City shall notify the Training Center of their intent to have employees participate, and if so, the number who will be participating.
  - 4. <u>Promptly Pay Training Center Invoices</u> Appendix A includes the annual 2015 charges which the City is agreeing to pay. The Training Center will bill the City in the months of January, April, July, and October. These billings will be for the current quarter, and will be due upon receipt.

#### C. Additional Training

The classes provided under this agreement are listed in Appendix B. The City may participate in other classes offered by the Training Center, however, they will pay the same rate for such classes as other customers.

#### D. Annual Meeting

During September the Training Center shall schedule a meeting with the City during which time the parties will discuss the following: (a) Services provided and received and any associated problems, (b) The next year's budget as established by the Training Center for Safety Training costs, and (c) Desirability by both parties to continue with the Safety Training program.

- E. Liability Each party agrees to assume responsibility for all liabilities that occur or arise in any way out of the performance of this agreement by its personnel and to save and hold the other parties, including their respective employees and officials, harmless from all costs, expenses, losses and damages, including the cost of defense, incurred as a result of any acts or omissions of the parties' employees relating to the performance of this agreement.
- F. Modification of This Agreement This agreement may be modified only with the consent of both parties. To that end, the Training Center shall convene no less than one meeting each calendar year in order to solicit feedback from the City on how services could be modified and/or improved.
- G. Termination of This Agreement Either party may terminate their participation in this agreement by providing 120 days' notice of their intent to withdraw. In the event the Training Center is unable to provide services as outlined in this agreement, the City shall be reimbursed for any services paid for but not yet received.

#### APPENDIX A

#### Normal Training Charges

For 2015 the City of Camas shall pay to the Training Center a total of **\$9,912.00 for** normal training conducted.

This is based on an employee count of **59** employees, representing a cost of approximately **\$168.00** per employee per year for all training outlined in Appendix B.

#### Summer Crew Charges

In addition to the 59 regular employees covered under this contract, the City of Camas utilizes Summer Crew employees and desires to have those employees trained as well. Summer Crew employees will not be trained in all disciplines each year, but will receive training in up to five classes each summer. The City of Camas shall pay \$100 per employee for Summer Crew personnel. It is anticipated that Camas will utilize 10 Summer Crew employees during 2015. This will result in a cost of \$1,000 in addition to normal training conducted.

#### **Total Training Charges**


The sum of Normal Training and Summer Crew Training is \$10,912.00 for 2015. This will be billed to the City of Camas in four quarterly invoices of \$2,728.00 each.

#### SUBJECT: 2015 CDBG Application

Staff is proposing to submit a CDBG application for the 2015 funding round. The proposed project will make improvements to a section of NE Franklin Street between NE 15<sup>th</sup> and NE 19<sup>th</sup> Avenues, as depicted on the attached image. This is similar to a number of past "Neighborhood Improvement Projects" that have successfully upgraded several older neighborhoods in Camas. Some examples include multiple projects in Oak Park, Tidland Heights, SW 6<sup>th</sup> Avenue, One-Stop Neighborhood, E. 1<sup>st</sup> Avenue, Crown Park, and several others. These types of projects typically include upgrades to the existing under-lying utilities (water & sewer), ADA ramp improvements, followed by reconstruction of the existing roadway surface. For many years, this stretch of Franklin Street has been classified as "Failed" due to severe cracking and failure of the under-lying base material.




Figure 2 Franklin St. looking North

The total project construction cost is estimated at \$422,000. Of the total, staff proposes to request CDBG Funding in the range of \$210,000, which will fund the cost of the proposed street and water, and a portion of the sewer system improvements. Engineering, preparation of Plans and Specifications, and Construction Management will be done by Camas staff. The remaining expense, about \$212,000., will be funded by the Camas Sewer Utility Fund. The cost of the individual system components (including sales tax) are listed below:

This section of Franklin Street, and the surrounding neighborhoods, has not been eligible for CDBG Funding in the past. We expect this to be the first of several projects aimed at improving this older neighborhood.

Staff's goal is to provide information about the proposed application, and to confirm your desire to move forward with the application.

A public Hearing at a future Council Meeting is required to provide a formal opportunity for public input on the proposal. We expect this to occur at the meeting scheduled for November 3, 2014.

2015 CDBG Memo 9/26/2014

#### **CDBG Background**

Community Development Block Grant (CDBG) is a funding opportunity originating from the U.S. Department of Housing and Urban Development (HUD). CDBG Funds are available through the Clark County Urban County Policy Board (UCPB) which is a group consisting of a representative from each local municipal jurisdiction, usually the Mayor or City Administrator. Funds are available through a competitive grant application process for a limited pool of available funds. The amount of available funds varies annually. Grants may be no less than \$50,000, and up to a maximum of \$300,000 per application.

Eligibility is based on economic need as determined by information collected by the U.S. Census Bureau. Using data from the most recent U.S. Census, HUD compares income data on larger Census Tracts which are made up of several Block Groups. HUD updates eligibility information periodically when new economic information is made available through the U.S. Census Bureau.

Since 1985, Camas has secured 33 separate CDBG Grants totaling more than \$5 million.

#### RESOLUTION NO. 1311

A RESOLUTION of the City of Camas relating to the multi-family property tax exemption program provided for under the Revised Code of Washington (RCW 84.14); expressing intent to designate three areas within the City of Camas as Residential Target Areas; and establishing a public hearing time and date for consideration thereof.

WHEREAS, RCW Chapter 84.14, "New and Rehabilitated Multiple-Unit Dwellings in Urban Centers," establishes a purpose to encourage and increase residential opportunities, including affordable housing opportunities, where the governing authority of the affected city has found there are insufficient housing opportunities and to stimulate the construction of new multi-family housing and the rehabilitation of existing vacant and under-utilized buildings for multi-family housing in urban centers; and

WHEREAS, the City of Camas, pursuant to Chapter 84.14 of the Revised Code of Washington (RCW) intends to designate three Residential Target Areas for the allowance of a limited property tax exemption for new multi-family residential housing; and

WHEREAS, the first intended Residential Target Area to be designated is described as the "Downtown District" and generally located between NE Adams Street and NE Garfield Street and between the area southeast of the Mill Ditch and northeast of the Burlington Northern Pacific Railway; together with that area of land located between NE Garfield and NE Joy and southeast of NE 3<sup>rd</sup> Avenue and northeast of the Washougal River; and, together with that area located between NE Division and NE Adams and southeast of the Mill Ditch and northeast of NE 6<sup>th</sup> Avenue; and

WHEREAS, the second intended Residential Target Area to be designated is described as the "NW 6<sup>th</sup> Avenue Corridor District" and is generally located between NW Ivy Street and NW Drake and south of NW 7<sup>th</sup> Avenue and north of NW 6<sup>th</sup> Avenue; and WHEREAS, the third intended Residential Target Area to be designated is described as the "NE 3<sup>rd</sup> Avenue District" and is generally located south of NE 3<sup>rd</sup> Avenue, west of NE Sumner and northeast of NE 3<sup>rd</sup> Loop; and

WHEREAS, in accordance with RCW 84.14.040, a public hearing is required prior to designation of a Residential Target Area(s);

NOW, THEREFORE, BE IT RESOLVED by the Council of the City of Camas as follows:

#### Section I

The City Council, pursuant to Chapter 84.14 of the Revised Code of Washington (RCW) intends to designate three Residential Target Areas (Downtown District, NW 6<sup>th</sup> Avenue Corridor District, and NE 3<sup>rd</sup> Avenue District) for the purposes of providing an economic incentive opportunity in the form of a limited property tax exemption for new multi-family residential housing.

#### Section $\Pi$

The City Council pursuant to RCW 84.14.040 does hereby schedule a public hearing to consider the designation of the aforementioned three Residential Target Areas, with the intent to implement a multifamily property tax exemption program, on Monday, December 1, 2014, at 7:00 PM or as soon thereafter as it may be held in the City Council Chamber of the Camas Municipal Building, 616 NE Fourth Avenue, Camas, which public hearing shall be duly noticed pursuant to the provisions of RCW 84.14.040(3).
