A general encroachment permit is required for construction or maintenance activity conducted within the public right-of-way (ROW), including the following activities: "... dig, break, excavate, use, occupy, tunnel, undermine or in any way obstruct or disturb any street, alley, sidewalk, highway, thoroughfare or other public place, or to fill, place, leave or deposit in or upon any such public street, highway, alley, thoroughfare, sidewalk or public place any article, material or thing whatsoever tending to encroach upon or to obstruct, disturb or interfere with the free use of the same, or to place, erect or maintain any structure, including curbs, gutters, sidewalks, driveways, paving, valley gutters, or sidewalk fronting strips in any city right-of-way ..." - 5. Types of Permits:
 - Sidewalk and/or Driveway:
 - Applies to new sidewalks/driveway approaches; removal & replacement of existing sidewalks/driveway approaches; and retrofitting of existing.
 - Street Tree New or Remove & Replace:
 - New trees or removal & replacement of existing trees.
